Common rules of the trade fair bank



for participants

of the 30th International Trade Fair of Practise Enterprises Prague, March 19th to 21st, 2025

- The only bank of the fair is Antre Bank.
- Each participant will be provided with a trade fair account with Antre Bank for the purpose of trade fair trading. Practise enterprises from the Czech Republic that already have a current account with CEFIFBANK can apply for a transfer of the balance to Antre bank's trade fair current account. Please inform us at antre@heroldovysady.cz.
- Every practise enterprise will receive cash in the amount of 20 000 fictitious CZK. Antre bank will distribute fictitious banknotes with the following face values: 20, 50, 100, 200, 500, 1 000, 2 000, 5 000 CZK.
- Every public visitor will receive cash in the amount of 10 000 fictitious CZK at the Antre bank stand, which can then be spent at the individual stands. If they do not spend it, they return it to the Antre bank stand before leaving the fair.
- The amount will be paid through Antre Bank. You must go to the Antre Bank stand to fill in a document (fictitious withdrawal ticket) and collect the cash. You can then start trading in cash with other companies.
- Any additional cash amounts will be paid to the participant or rather the practise enterprise
 through Antre bank during the fair based on a properly filled in withdrawal ticket after
 confirmation of a sufficient account balance.
- Transactions can be carried out in cash or non-cash in the form of trade fair cheques, which
 will be available for participants at the Antre bank stand or can be downloaded electronically
 and printed out from our website https://antreprague.cz/. The cheque will be filled in by the
 practise enterprise (seller) for the buyer (visitor or other practise enterprise) who will sign the
 cheque.

- In order to deposit earnings, cash or fair cheques, into the Antre Bank account, you must present a completed fictitious deposit ticket in the case of cash, which will be available at the Antre Bank stand or can be downloaded electronically and printed out from https://antreprague.cz/, or properly filled in and certified fair cheques. Fictitious cash or gained fair cheques will be issued by Antre Bank staff and deposited into your Antre Bank fair account no later than 15:30 on the first and second day of the fair, cash and cheques acceptance will end at 11:00 on the last day.
- Please hand in any remaining fair cash on the last day of the fair, March 21st, 2025, by 12:00 at the Antre Bank stand.
- Do not leave large amounts of cash on you, return excess cash to the bank each day. You will help us to ensure the circulation of money. Thank you!
- The fair accounts of the participants, the practise enterprises, will be closed after the end of
 the fair and the balance will be transferred to the current account of the Czech practise
 enterprises. Foreign enterprises will be sent a trade fair cheque in euro to the company's
 e-mail address according to the current exchange rate (the foreign participant can add the
 relevant amount to their account in their home country).
